Description: GOOGLE FIBER STATUS

IN LATE JULY 2012, GOOGLE FIBER, INC. ('GOOGLE FIBER'), THE PARENT COMPANY OF GOOGLE FIBER KANSAS, LLC AND GOOGLE FIBER MISSOURI, LLC, ANNOUNCED ITS NEW AND INNOVATIVE BROADBAND INTERNET AND VIDEO SERVICES. THE SERVICES WILL BECOME AVAILABLE IN KANSAS CITY, KS; WESTWOOD, KS; WESTWOOD HILLS, KS; MISSION WOODS, KS; AND KANSAS CITY, MO. (GOOGLE FIBER IS SEPARATELY AND CONCURRENTLY FILING A FORM FCC 396-C ON BEHALF OF ITS SUBSIDIARY GOOGLE FIBER MISSOURI, LLC, FOR ITS EMPLOYMENT UNIT IN THE KANSAS CITY MARKET THAT INCLUDES THE OPERATIONS OF BOTH GOOGLE FIBER MISSOURI, LLC, AND GOOGLE FIBER KANSAS, LLC.)

ONCE FULLY DEPLOYED, THE SERVICES WILL PROVIDE CUSTOMERS IN THE SERVICE AREA WITH GOOGLE FIBER INTERNET SERVICE WITH UPLOAD AND DOWNLOAD SPEEDS OF UP TO 1 GIGABIT PER SECOND AND IPTV SERVICE NAMED GOOGLE FIBER TV WITH MORE THAN 150 CHANNELS. ON SEPTEMBER 13, 2012, GOOGLE FIBER OPENED ITS CUSTOMER PORTAL THROUGH WHICH RESIDENTS IN SELECT AREAS OF KANSAS CITY, KS AND KANSAS CITY, MO COULD CHOOSE WHICH GOOGLE FIBER SERVICES THEY WOULD LIKE TO OBTAIN IN THEIR HOME.

AT THIS TIME, THE GOOGLE FIBER INTERNET AND GOOGLE FIBER TV SERVICES ARE NOT YET LIVE IN CONSUMERS' HOMES; THE COMPANY CONTINUES TO BUILDOUT ITS FACILITIES AND PREPARE FOR INSTALLATION OF THE SERVICE IN RESIDENCES. DESPITE THE FACT THAT GOOGLE FIBER ONLY RECENTLY COMMENCED OPERATIONS, GOOGLE FIBER HAS DESIGNED AND IMPLEMENTED AN EEO PROGRAM IN KEEPING WITH SECTION 76.75 OF THE COMMISSION'S RULES.
